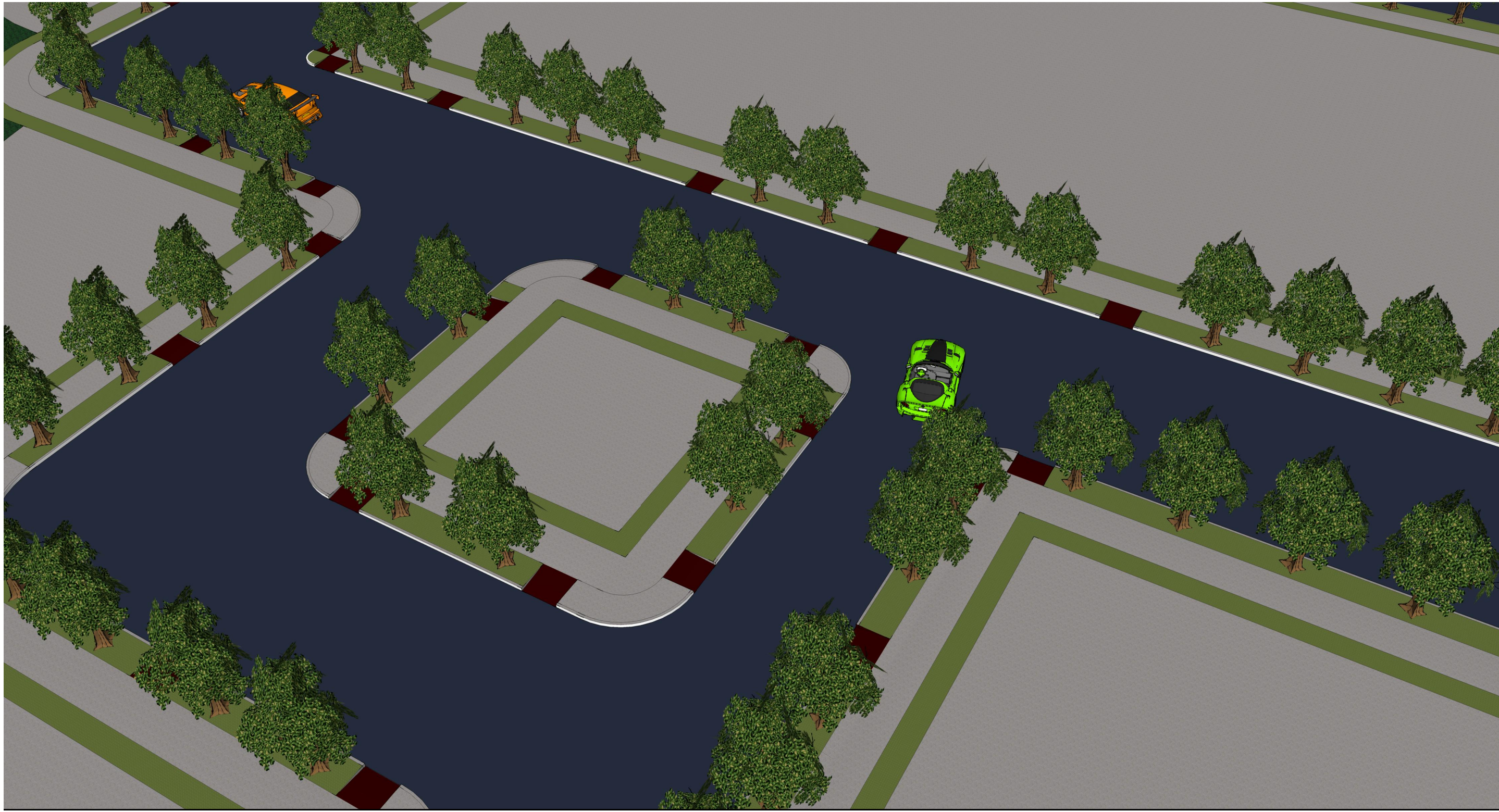

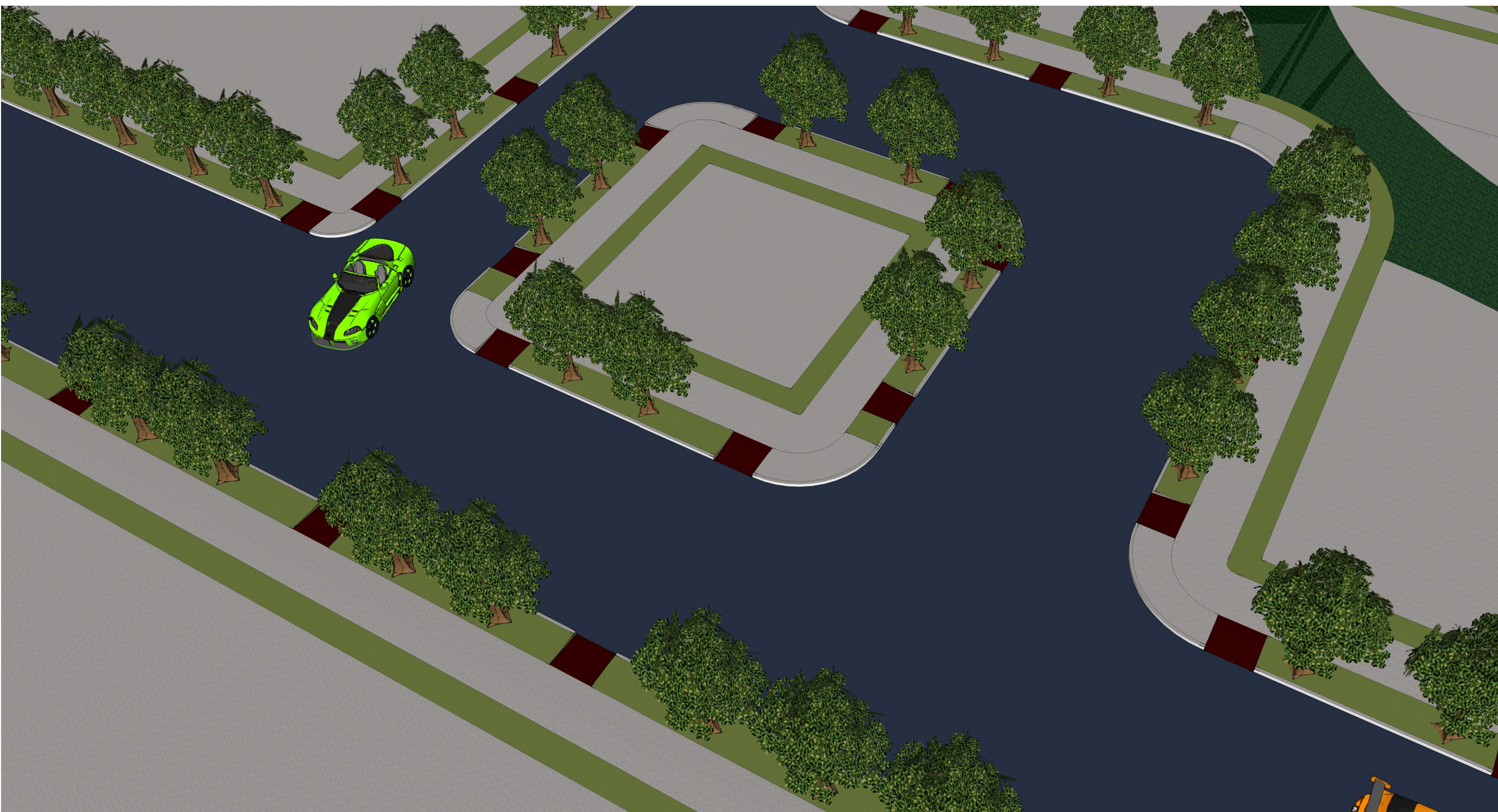

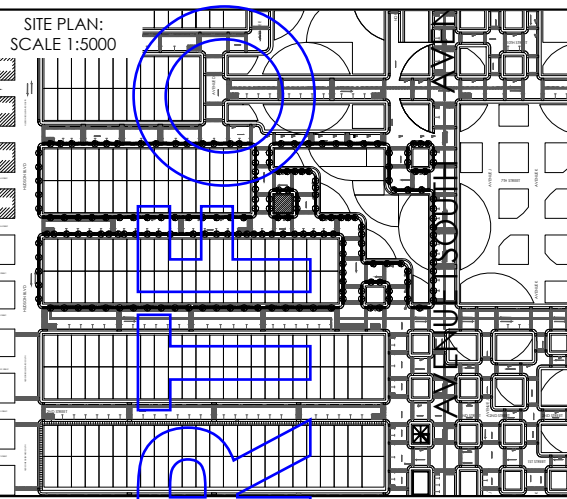
BLOCK 01 037 - NORTHWEST VIEW
